The EPL code for this contribution is approved. Please ensure the third party code is removed from CVS (as you had checkintocvs based on Parallel IP). Since the files in #2 and #3 are generated by EPL code, we do not have to remove them. Results and to do's:

1. start\_cimom.bat and any other Sun WBEM files need to be removed.
2. files are generated by EPL code, we do not have to remove them
  - a. IBMSchema
  - b. DSICAT\_Root\_IBM 5.1.0.40
  - c. IBMMOF
3. files are generated by EPL code, we do not have to remove them
4. Remove org.xml.sax – new CQ to be submitted.

#### 1. Apache Xerces ( <http://xerces.apache.org/> )

We use the org.xml.sax package from this library. Aperi also uses this library ( <http://www.eclipse.org/aperi/documentation/r2/install.php> ).

Tom: What level of Xerces are you using? We already obtained approval for 2.8.0. If you are using that version, I could get this approved very quickly. *RESPONSE: 2.8.0 OK to use*

#### 2. Apache Log4j ( <http://logging.apache.org/log4j/1.2/index.html> ).

We use org.apache.log4j package from this library for logging purposes. Aperi does NOT use this library. Pls. let us know, if we can use this library or not. We can switch to internal java logger or switch to Aperi logger. We can switch to java default logger and the effort is very minimal.

*Switched to Aperi logger – no logger an issue*

#### 3. Sun WBEM

We use this library and the wbemservices for CIMOM. Users have to download this from <http://wbemservices.sourceforge.net/>

Tom: Right. We will not be able to get approval for this, but if users download, we are OK.

#### 4. SBLIM CIMClient

We use this CIMClient library. Aperi also uses this library from [http://sourceforge.net/project/showfiles.php?group\\_id=128809](http://sourceforge.net/project/showfiles.php?group_id=128809)

Tom: What level of the CIM Client are you using? We just got the OK to use 1.3.3. If you are using that version, I could get this approved quickly as well. *RESPONSE: will use 1.3.3 OK to use*
