1. New Date for the QC Meeting

2. ORGA-39: Infrastructure for Integration Environment / Quality Process Proposal

Sybille Peter has clarified her comments on ORGA-39 and ORGA-37. We agreed that this approach will be edited for the SC.

Proposal / Approach:





- F. Wöhrl and S. Dirsch arrange an appointment where the process / the proposal for the SC will be prepared.
- The guidelines from ORGA-37 shall be defined as a general agreement for this process. Examples:
 - Every company that provides a Committer has to receive a contract (e.g. paid work time accounts, similar to AUDI maintenance contracts) so that the Committer is able to work through the incidental review tasks.
 - Companies which receive a development contract and that provide a Committer who is involved in the development process cannot approve a MergeRequest on their own. A review by at least one other Committer of another company must be made.
 - o ...
- After the proposal and the guidelines are gathered and prepared as a document for the SC, the status will be adopted and resolved at the QC.
- F.Wöhrl as the Head of QC presents the status adopted by the QC (document) personally at a SC Meeting.

3. ORGA-67: Setup Oracle Database for Integration Environment

- Approach similar to ORGA-39
- QC sets requirements for a test database. Examples:
 - o At least 200000 tests
 - 100 channels per measurement
 - 100000 measuring points per channel
 - Different channel data types
 - Context data for order and result for each test
 - If necessary: import / use public test data (weather data)
 - Delivery of the model as DUMP-File
 - Delivery of the mass data files as ZIP
 - Configuration example for ODS Servers
- After the requirements are agreed on and resolved by the QC → Presentation at the SC (due to commissioning of the implementation)
