1. Compilation of SC and AC

According to the openPASS charter at least one seat is allocated in the SC to each class of members different to Driver Members. Since the openPASS WG has only one Service Provider and one User Member, it is not necessary to elect a representative of the Service Provider and the User Member.

Currently, the AC consists only of Driver Members, the project lead and invited guests. The WG is discussing whether the charter should be adjusted such that Service Providers and/ or User Members have a seat in the AC. A change in the charter would cause a lot of effort at the partners because the legal departments have to be consulted.

2. Release v0.9

The last release review was done for v0.8 and lies within the last 365 days. Thus, no release review for v0.9 is required. There can be as many releases within these 365 days as possible.

Currently, the CI for merge request $\frac{\#78}{100}$ is failing. This is due to some documentation build fails. BMW is working on removing the warnings to fix the issue.

Mercedes is checking the PCM E2E test setup. The according issue can be found here.

3. New openPASS slides

New slides have been presented by Thomas. The new slide set have been discussed. Slide 5: Rephrasing of "OpenDRIVE" to "map format" Slide 11: Jan will propose another wording for "Counterfactual" BMW will propose a new slide with exemplary use cases of openPASS e.g. the use of openPASS in SET Level or OSCCAR.
